A. American Rescue Plan Act – Local Fiscal Recovery Funds.

The ARPA funds are based on population. The Village's portion is estimated to be \$43,018.78. To be eligible we will need to have a valid DUNS number before registering with the federal government SAM database. The final step will be filing with the Wisconsin Department of Revenue to request funds. As required by the American Rescue Plan Act, each applicable municipality will receive 50 percent of its allocation in 2021 and the remaining portion in 2022. Julie has updated the DUNS account and will register with the SAM database. When the forms are available, she will submit a request to the Department of Revenue.
